HOLDING AGREEMENT:

A \$400.00 deposit is required to hold your puppy. The seller guarantees that the dog will not be sold to any party other than the buyer as long as the buyer adheres to the Picking Up Your Puppy guideline. The \$400.00 deposit is nonrefundable and will be applied to the purchase price of the dog. You may send a personal check or money order. The balance due must be paid when picking up the puppy or before shipping. If you are paying when you pick up the puppy it needs to be cash or money order. **NO PERSONAL CHECK WILL BE ACCEPTED THE DAY OF PICKUP!!!!**

PICKING UP YOUR PUPPY

Your puppy needs to be picked up between 8-9 weeks of age. If you have not picked up the puppy by 9 weeks of age the contract is void. All fees are to be paid in full before you pick up the puppy. Shipping is available for an additional charge which will include the crate and health certificate. Puppies cannot be shipped until 8 weeks of age.

GUARANTEE:

Puppies are to be in good condition for 72 hours after the puppy is picked up. The buyer agrees to have the puppy examined by a licensed veterinarian at buyers expense within the first 72 hours after taking possession. If the veterinarian finds the puppy has a serious condition the puppy/dog will be returned to the breeder for a replacement out of a future litter, at no time will money be returned or refunded. Viral, bacterial colds or infections such as Coccidia or Giardia are easily treated and are not covered in the health guarantee. Umbilical hernias also referred to as "outie" belly buttons are not covered in the health guarantee. Bordatella- a raspy cough – is common when puppies are transported to a new home and is not covered by the guarantee. All puppies are treated and vaccinated for distemper, parvo, coccidia, giardia and worms before they leave our kennel. However, you need to be aware that these things can arise and that they are usually not serious and are easily treated and we will not cover the treatment for them.

The buyer shall provide proper nutrition, vet care, shelter and exercise. If buyer is unable to care for or chooses not to keep the dog, Dutchman's Kennels retains the right to recover the puppy. The buyer must notify Dutchman's Kennels and give the seller first right to the dog. The original purchase price of the dog is non-refundable even when the dog is healthy. . This pup must never be sold to a pet store, broker, puppy mill or surrendered to a shelter.

Pups are shipped at 8 week of age and guaranteed for 3 days from shipping date. Will have 2nd set of shots and dewormed, vet health certificate, crate and toy. Buyer is responsible for shipping charges/ground delivery. Pup must have vet check-up at buyers expense within 72 hours of delivery to insure health guarantee. In the event of a pup being returned for any reason or a replacement pup, buyer is responsible for shipping charges/ground delivery.

REGISTRATION:

All puppies are sold with AKC Registration papers either Limited or Full Registration unless contracted otherwise.

_____ The puppy sold on Limited Registration . It is understood that the puppy will be spayed/neutered and not to be used for breeding. If dog is used for breeding when Limited Registration was given Breeder has the right to take Buyer to court for breach of contract and \$5000.00 plus court expenses for not following contract and spaying/neutering dog as agreed. If this does happen all contract guarantees are null and void.

_____ The puppy is sold on Full Registration in which it will be eligible for all registry events and offspring will be eligible for registration.

All of our puppies are guaranteed to be purebred. After the buyer assumes physical possession the seller holds no responsibility for the puppy .

NUTRITION AND FOOD AND LIFETIME PUPPY REPLACEMENT:

To get a **TWO YEAR PUPPY REPLACEMENT GUARANTEE** your pup/dog must be fed Life’s Abundance Food. It must be on Auto ship. It must be ordered from our kennel website. If at any time you cancel the food or do not order the amount needed to feed your dog according their size and age , the guarantee will be null and void.

I acknowledge that this is a legal and binding contract and have reviewed and agree to the terms listed. The buyer will also maintain up to date vaccines, worming and to keep the puppy/dog in humane conditions. This contract applies only to the original purchaser and in NOT transferable. When a deposit is received the purchaser automatically agrees to the terms of this contract, even if both the Breeder and Purchaser have not yet signed the contract. Should there be any dispute; legal Venue shall be State of SD. McCook County.
